Owner's Agreement

I understand that the training and boarding fees will be paid in advance for each month, and all incidental cost will be billed at the end of the month. I hereby grant a lien to Curt Fuller for all unpaid charges.

This horse, to the best of my knowledge, has not been exposed to any contagious or infectious disease for two weeks prior to this boarding date. I hereby consent to any medical treatment deemed advisable in an emergency.

If Fuller Training Stables or any of their representatives are not able to contact the above veterinarian, I consent to treatment by Fuller Training Stables or their veterinarian. I understand all charges thus incurred will be billed to me.

Every precaution is taken to protect the horse from illness, accident, fire and theft. Fuller Training Stables and/or management shall not, while exercising reasonable care, be held responsible for accident, illness, fire or theft.

The horse owner understands that Fuller Training Stables does not carry any of the outside horses on any public liability, accidental injury, theft, or equine mortality insurance. All risks connected with the horse are to be borne by the horse owner or owners.

I understand that shoeing, veterinarian services, hauling and any miscellaneous expenses are additional costs and will be billed accordingly. These additional expenses are due and payable upon billing.

The horse owner further agrees to pay a 10 percent commission to Fuller Training Stables, if said horse sales while in training or within a month after having been in training or presented by us.

Venue, costs, and attorney's fees:

It is further agreed that in the event it is necessary for Fuller Training Stables to hire an attorney to enforce the terms of this contract, or to defend against an action brought by the horse owner, whether or not it results in a lawsuit filed in a court of competent jurisdiction, Fuller Training Stables shall be entitled to reasonable attorneys' fees and costs. It is agreed between the parties that the venue of said court action shall be exclusively limited to the county of Twin Falls, State of Idaho.

The monthly boarding will be \$160.00 for a corral, \$190.00 for a run, or \$235.00-250.00 for a stall. The monthly training will be \$350.00, plus boarding fee. Horses in full-time training for the year will receive preference.
